Right of Way Construction Permit Application

ADDITIONAL INSTRUCTIONS AND INFORMATION

This permit application is required for all construction or expansion of facilities and maintenance or repair of existing facilities that are in, under, or over the public right-of-way.

Checklist for Permit Application Right-Of-Way (Row) Use

- The applicant must submit the Application with a copy of plans; a copy of a legible site-specific traffic control plan or street closure plan, if required; a line drawing or aerial photo.
- Applicant must submit Valid Insurance, Performance Bond and Maintenance Bonds for the amount of the entire project cost.
- Plans must follow ordinance requirements and be prepared in accordance with City Infrastructure Design Standards.
- Application must be signed by someone authorized to bind Owner of facilities.
- Forty-eight hours before commencing work, the contractor shall contact the City at 469.550.0356.
- Locate marks must be removed when work is complete.
- The Right-of-Way Permit must remain on site when work is being performed.
- The Registration Certificate must remain on site when work is being performed.

If there will be sub-contractor on the project, please provide a list that includes the company name, address, name of sub-contractor's on-site supervisor, sub-contractor 24-hour contact phone, sub-contractor's e-mail and certificate of insurance.

Facility locates must be requested and verified by the Engineering/Public Works Department in advance of submitting a permit application. All requests for locates of the City infrastructure shall be made directly to the City.

Notification to affected property owners. Except in the case of an emergency, whenever excavation is required in the right-of-way adjacent to an occupied property, the right-of-way user shall notify the property owner of the activity through the use of a door hanger, at its sole cost and expense, which shall include all information required in Division 2 of the ordinance.

Certificated Telecommunications Provider (CTP)

A CTP must provide evidence that the CTP has acquired authorization from the PUCT pursuant to state law, prior to obtaining a permit to use public right-of-way. The CTP's right to use and occupy the public right-of-way shall not be exclusive, and the City shall have the right to exercise its police powers and manage its public right-of-way, based on the Act and all other state or federal laws.
